Ministry of Labour Announces Compliance Blitz Schedule for 2018-2019

April 9, 2018

The Ontario Ministry of Labour has announced its annual "blitz and initiatives" schedule for 2018-19, designed to encourage and enforce employer-compliance under the *Employment Standards Act (ESA)* and *Occupational Health and Safety Act (OHSA)*.

ESA Compliance

This year, we expect to see increased scrutiny of employer-compliance under the new requirements established by Bill 148. This may include a review of an employer's policies and practices related to:

- minimum wage
- vacation time and pay
- personal emergency leave
- public holidays
- equal pay for equal work

The Ministry of Labour has specifically announced the following *ESA*-related blitzes and initiatives for the April 1, 2018-March 31, 2019 period:

Construction (Province-Wide)	May 1- August 31, 2018
Small/Independent Businesses (Central East Ontario	September 1- December 31, 2018
Retail Trade, Excluding Restaurant and Grocery (Central West Ontario)	October 1, 2018- January 31, 2019
Independent Grocery (Eastern Ontario)	June 1- September 28, 2018
Hotel/Motel Accommodations (Northern Ontario)	August 1- October 31, 2018
Golf Courses (Western Ontario)	June 1- September 30, 2018

Worker Training for Temporary Help Agencies (Central West Ontario)	June 1, 2018- March 31, 2019
